



## **CONTRACTOR MEMBERSHIP**

The Mechanical Contractors Association of Eastern Missouri aims to promote the mechanical contracting industry, to foster the meeting and exchange of ideas, technical data, and business information between members, the national association, other associations and manufacturers. We represent the membership in labor relations, regulatory and legislative matters that govern the industry.

All Contractor Members must be signatory to Local 562. In addition to \$500 annual membership in the local association, all members of MCA-EMO are also members of the Mechanical Contractors Association of America (MCAA) and are required to pay an additional \$.08 per man-hour worked for national dues.

### **Audit Committee**

The Audit Committee assists the Board in fulfilling its responsibilities to perform an annual financial audit. The Committee is comprised of three members. It meets twice a year to review the Audit, Management Letter, and other required auditor communications with the Auditors and MCAA staff. The Audit Committee also oversees the selection of the independent auditor.

### **Education Committee**

The Education Committee identifies issues and trends to develop the educational curriculum for the annual convention and to The Education Committee advises the MCA-EMO staff on key industry issues and member needs, providing direction and guidance on education/training goals and objectives for the association. The committee discusses the most relevant issues, content, formats, and delivery methods, as well as identifies potential participants for educational program activities.

### **Joint Apprenticeship Training Committee**

The Joint Apprenticeship Training Committee works with Local 562 to provide the mechanical construction industry with the most highly trained and skilled workforce possible. We jointly identify training needed to address specific workforce or construction owner requirements. We work together to improve our apprenticeship and ongoing training programs for all members of Local 562 on topics including safety, technical skills, welding, HVAC service, etc. [The chairman and at least one other contractor member shall participate on the Joint Apprenticeship Training Committee with members of Local 562 and the PIC.]

### **Safety Committee [Joint Safety]**

The Safety Committee discusses relevant service issues and seeks out education and training opportunities that meet the ongoing and changing needs of the service mechanical contracting industry for contractors and the mechanical trades. The committee will assist MCA staff in ensuring the quality of training programs and make recommendations for changes and improvements based on constituent needs. [The chairman and at least one other contractor member shall participate on the Joint Safety Committee with members of Local 562 and the PIC.]



### **Service Committee [Joint Service]**

The Service Committee discusses relevant service issues and seeks out education and training opportunities that meet the ongoing and changing needs of the service mechanical contracting industry for contractors and the mechanical trades. The committee will assist MCA staff in ensuring the quality of training programs and make recommendations for changes and improvements based on constituent needs. [The chairman and at least one other contractor member shall participate on the Joint Service Committee with members of Local 562 and the PIC.]

### **Weld Bureau [Joint Weld Committee]**

The National Certified Pipe Welding Bureau (NCPWB) is a subsidiary of the Mechanical Contractors Association of America (MCAA). NCPWB was established to keep contractors informed about welding/brazing technology, allow for the transfer of welder/brazer certifications, and to simplify the welding/brazing qualification practices. [The chairman and at least one other contractor member shall participate on the Joint Weld Committee with members of Local 562.]

### **Young Professionals Committee**

The Young Professionals Committee (YPC) guides and recommends activities for the MCA of Eastern Missouri that educate and build community through various learning opportunities that are relevant to our industry's professionals.
